- Session fees are due when booking the session to reserve your time. Refund of fee requires 24 hour cancellation notice.
- A Fine Print Photography retains all copyright ownership of all images created as a result of this contract, and images may not be reproduced, duplicated or scanned for any reason without our expressed written permission.
- A Fine Print Photography reserves the right to use reproductions of any images, taken during your session, for the purpose of display, illustration, advertising, competition or publication including but not limited to our Blog and Facebook.
- You shall have no claims in any manner regarding A Fine Print Photography or publishers of these photographs, present or future. All images are copyrighted to A Fine Print Photography.
- All portrait proofs are digital and can be viewed online upon request. For paper proofs, a retainer of \$300 is required. This retainer is non-refundable but may be applied as deposit to portrait orders from this sitting only.
- All orders must be paid in full at the time the order is placed. No part of any order will be delivered until the balance is paid in full. Payment plans available for orders over \$500
- Checks returned by the bank for any reason are subject to a \$25.00 service charge and will constitute cancellation of any order if they are not paid in full within three days of notification by A Fine Print Photography.
- Texas state sales tax will be charged on all orders.
- Prices are guaranteed for 60 days from date of session. All items ordered after that date will be charged at current portrait prices. For images to be reposted online after 10 days there will be a \$25.00 re-post fee. Retrieval of archived images after 1 year requires a \$100.00 minimum order.
